New Billing Procedures for RHC and FQHC

The State of Wyoming's EqualityCare Health Benefits Program is now requiring RHC's and FQHC's to bill all covered EqualityCare services that were performed in addition to the encounter codes. The encounter rate established by EqualityCare includes ALL services provided during the encounter regardless of actual charges. The date(s) of service for the service(s) performed must be within the date(s) of service of the encounter(s) or the entire claim will deny.
